



## NOTICE TO NATURAL GAS CUSTOMERS IN GAS DISTRIBUTION AREA OF ELEKTROMETAL – DISTRIBUCIJA PLINA D.O.O.

(City of Bjelovar and the Municipalities of Veliki Grđevac, Velika Pisanica, Nova Rača, Severin, Kapela, Rovišće, Ivanska, Štefanje and Berek)

## Dear Customers,

In relation to the notice from the Croatian Energy Regulatory Agency (HERA), we would like to inform gas customers that in line with the Decision on the Amount for Tariff Items for the Public Gas Supply Service, new prices for the public gas supply service have come into force for end users for the period from 1 April to 31 December 2019. The new prices apply for all suppliers with respect to public service is applicable from 1 April 2019

According to the mentioned decision (Appendix 1), prices for natural gas from 1 April 2019 are as follows:

- The tariff item for delivery quantity of gas for tariff model TM1 billed metering place with an annual gas consumption less than or equal to 5,000 kWh (≈ 540 Sm³) amounts to 0.2608 kn/kWh (excl. VAT);
- 2. The tariff item for delivery quantity of gas for tariff model TM2 billed metering place with an annual gas consumption greater than 5,000 kWh, while less than or equal to 25,000 kWh (≈ **2,700** Sm³) amounts to **0.2520** kn/kWh (excl. VAT):
- 3. The tariff item for delivery quantity of gas for tariff model TM3 billed metering place with an annual gas consumption greater than 25,000 kWh, while less than or equal to 50,000 kWh (≈ **5,400** Sm³) amounts to **0.2498** kn/kWh (excl. VAT);
- 4. The tariff item for delivery quantity of gas for tariff model TM4 billed metering place with an annual gas consumption greater than 50,000 kWh, while less than or equal to 100,000 kWh (≈ 10.800 Sm³) amounts to 0.2476 kn/kWh (excl. VAT);

**Elektrometal – distribucija plina d.o.o. Bjelovar** as the distributive area operator began reading gas meters of end users which use the public gas supply service (households: tariff models TM1, TM2, TM3 and TM4), with planned completion to be on 5 April 2019.

The submitting of gas meter readings to the distributive area operator **Elektrometal – distribucija plina d.o.o. Bjelovar** can be done through the following channels:

**Note:** If the end user does not submit the gas meter reading information, for the period from the date the Decision comes into force, the supplier will determine the proportional number of days of gas consumption between the reading of the gas meter at the start and at the end of the billing period
